### **Terms of Conditions & Expectations**

**Evaluation Period.** Athletes are always under evaluation. Athletic performance, academic performance, attitude, availability, conditioning, and behavior will be evaluated on a continual basis by the coaching staff.

#### **Player Expectations.**

Practice hard! Play hard! Be a great and awesome teammate! Respect their coaches and teammates. Bullying will not be tolerated. Team goals should always be placed above personal goals. Communicate on the court with your teammates. Communicate with their coaches on game and practice expectations. ASK QUESTIONS!!!

#### **Parent Expectations & Conduct.**

- Parents, and spectators are expected to conduct themselves in a respectful manner toward all participants in games and practices. Conduct that is detrimental to the team or Program will not be tolerated. Abuse of this policy will result in (1) warning. The second offense will result in removal from game/facility and forfeiture of roster spot.
- Support your son and his teammates.
- Do not discuss your child's role or coach's decisions at tournaments or practice with other players or parents. If you have an issue, schedule a time to address it with the coach.
- We have a 24-hr rule. No complaints or questions should be directed to the coach until after 24-hrs. (Violation of this rule CAN result in forfeiture of roster spot.)

**Playing Time.** Playing time is not guaranteed to our PRIME and PREMIER teams. Coaches will not discuss playing time with parents. Playing time will be discussed between the player and the Coach. As a FINAL resort, the Director can be involved if all avenues between the player and coach have been exhausted. Do NOT come to the director if the player has not spoken with the coach about any questions

and concerns.

**Attendance.** Consistence attendance at practice and games is necessary for the success of player development and the Program. Communication concerning any missed practices and/or games is mandatory. Please contact the coach directly or use the team application for communications about missed practices and/or games.

**Assumption of Risk and Indemnification.** The undersigned Parent or Guardian understands that participation in sporting events, training, and activities may pose a risk of harm or injury to Participants and Spectators. The undersigned, on behalf of himself/herself and on behalf of the Minor Participant/Player, also hereby expressly assumes the risk of injury or harm in these activities and releases 220 from all liability for injury, illness, death or property damage resulting from the Minor Participant/Player activities or participation with 220. The undersigned, on behalf of himself/herself and on behalf of the Minor Participant/Player, agrees that if anyone makes a legal claim against 220 and/or any of its affiliates, that the undersigned, on behalf of himself/herself and on behalf of the Minor Participant/Player, agrees to indemnify, save and hold harmless 220 and its affiliates from any legal claim, including without limitation, loss, liability, damage or cost which may occur as a result of any such legal claim.
